Town of Interlaken Sign Study & Recommendations

The purpose of the study & proposal is to improve signage around the Town of Interlaken to enhance safety, deter illegal parking, provide clarity, and to revamp dilapidated signs. Where possible, the goal is to make use of current sign posts to reduce sign clutter.

In all, the survey identifies 22 sites where signs could be added or improved to achieve the aforementioned goals. The interactive map can be found <u>here</u>.
