#### Hi Colt,

This is Trent Davis with Interlaken Mutual Water Company. System # UTAH26055. We have received a notice that we must file for this order if we are unable to complete the requirement to meet the deficiency by July 1, 2020. We would like to file for this order and would like to know how we do so. We are waiting for grant approval to complete the project which we filed for last year but have not received as of yet and I believe that the Covid outbreak has slowed the approval process even more. The generator is sitting in the suppliers yard waiting for purchase, the contractors are ready to go to work, but we have been told we can not begin the process in any way until the grant is approved and funded otherwise it will be denied.

This creates a difficult situation for us. Because this is such a substantial amount of money we do not want to risk the loss of a grant on the project, we also do not wish to continue being in violation. \$1000 a quarter for the violation will also create further delays and issues.

Please let us know how you would like us to proceed and what paperwork we must file.

#### Hi Bart,

We recently excavated a water line from our house toward the main. Instead of finding a stub out, there was only a backflow preventer with rusted out pipes.

We called in the water masters who, after considerable hours of investigation and consultation, decided that we would need to find someone to perform a hot tap on the main. Witt Excavating agreed to locate the plumbing parts to repair the existing backflow device piping and saddle for the hot tap. The next day they performed the install.

I have paid for the entirety of the excavation cost, and would like Interlaken to repay me for the parts, equipment, and labor time associated with the rusted parts and hot tap. Either of the water masters can confirm the details.
