The PC comments include insufficient setback delineation; insufficient maximum building height delineation (for sensitive slopes); insufficient delineation of slopes on the property; Submit Special Hazzard Study & Geotechnical Report; insufficient waste debris dumpster location (is not noted), Temporary Portable Toilet location (is not noted), insufficient notes (work hours not stated, Proposed site disturbance area and associated square footage is not delineated, stormwater mitigations are not delineated; Dust and Mud Mitigation Measures are not delineated, and Sand, rocks & debris mitigation measures are not delineated, Dirt Storage not delineated, Materials Storage not delineated, and employee parking is not delineated, and the notes regarding the protections required for steel tracked vehicles, retaining wall design details & appearance details were not provided; and landscaping notes and details were not delineated or provided on the drawing submission.
